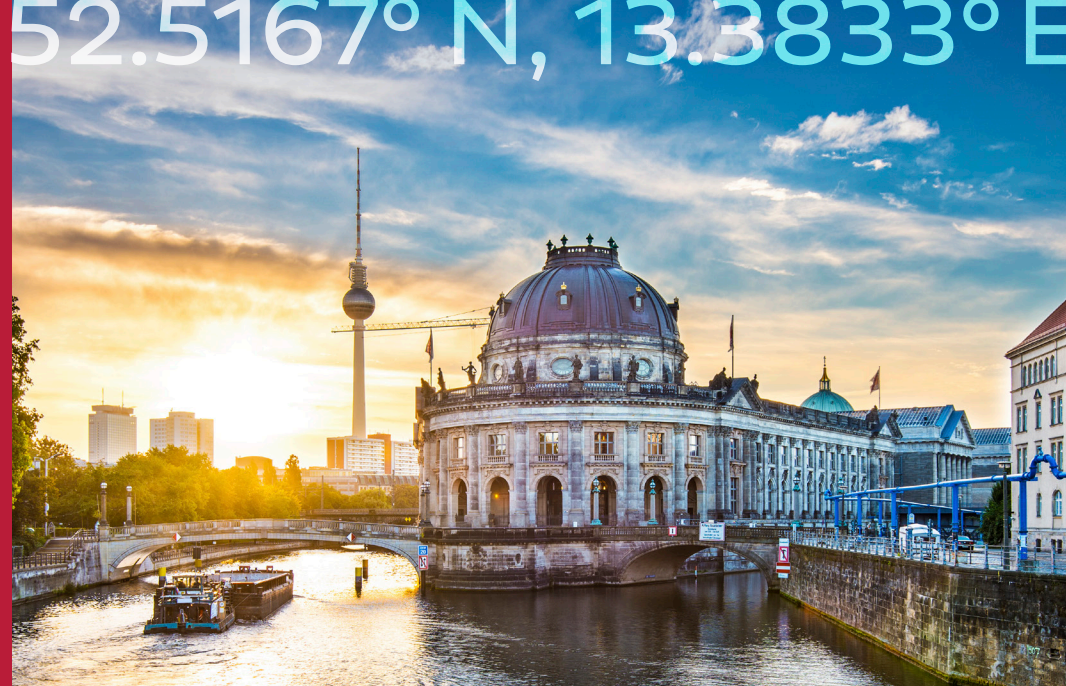

Program Courses

Intersectionality and Human Rights

Students will apply classroom theory to contemporary problems faced by constituents of Berlin nongovernmental organizations (NGOs) working with migrant and refugee populations. Students will also contemplate how human rights and transnational lawyering might assist Berliners facing multiple sources of discrimination.

History, Memory and Law

Students will consider how lessons from historical traumas can inform contemporary strategies of inclusion and anti-subordination of minorities in Europe, the United States or other parts of the world. Students will analyze how topics such as genocide, forced labor, colonialism and immigration are reflected in a society's law, policy and public history.

Course-integrated Excursions

High quality field trips with private guides to some of Berlin's most historically significant sites are incorporated into the curriculum of the Law and Critical Social Justice program, including the following excursions:

- Germany's Colonial Past
- Holocaust Memorials and Forgotten Victims
- Guided Tour of Ravensbrück women's concentration camp
- Site visits to Berlin NGOs working on hate violence and refugee/asylum rights

Authentic Cross-cultural Exchange

Humboldt University of Berlin students who are fluent in English will participate in classes and extracurricular activities. German, European and U.S. faculty members collaboratively teach each course.

Admission and Financial Aid

Admission

Admission to the program is open to law students who have completed at least one year of full-time or part-time study and are in good standing at an ABA-accredited law school. A very limited number of undergraduate or graduate students with a background international law or human rights may also be admitted to the program.

Financial Aid

DePaul students enrolled in ABA-approved study abroad programs qualify for financial aid. Non-DePaul students applying to this program should contact their home institution's financial aid office and request that a financial aid consortium agreement be sent to the Office of Financial Aid at DePaul University.
